III: MINIMUM EDUCATIONAL QUALIFICATIONS:

- A Degree in Engineering or Technology granted by statutory University.
- A Degree in Engineering or Technology granted by an Institutions empowered to grant such degrees by an Act of Parliament.
- A Diploma in Engineering or Technology granted by a State Council or Board of Technical Education established by a State Government in relevant discipline.
- A Diploma in Engineering or Technology granted by a University in relevant discipline.
- A Diploma in Engineering and Technology granted by an Institution recognized by the State Government or Central Government as equivalent to above.

IV. AGE: Age limit will be followed as per Apprenticeship Rules.

V. RESERVATION OF VACANCIES: Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD will be followed. Who are claiming reservation under SC/ST/OBC/PWD shall provide certificate as per Government standard format, failed which their claim for reservation will be considered as 'General' category only. If BC candidates claiming OBC category, they should bring OBC certificate as per the Govt. prescribed (OBC) format from the certificate issuing authority.

VI. MINIMUM PHYSICAL STANDARDS:

As prescribed in Clause 4 of the Apprenticeship Rule 1992, and amendments thereof if any.

VII. DURATION OF TRAINING:

The duration of Apprenticeship training will be for a period of one year as per Apprenticeship (Amendment) Act 1973.

VIII. PREVIOUS TRAINING/EXPERIENCE:

Candidates who have already undergone or are currently undergoing apprenticeship under Apprenticeship (Amendment) Act 1973, and/or having one year or more experience are **not eligible to apply**.

IX. SELECTION PROCEDURE:

Board of Apprenticeship Training (SR) is entrusted with the task of preparation of shortlist from the online application data. Shortlisting of candidates will be done based on the percentage of marks obtained in the basic prescribed qualification as applicable to the respective disciplines. Shortlisted candidates shall be intimated through their registered Email id. Shortlisted candidates have to appear for Certificate Verification at "Mangalore Electricity Supply Company Limited (MESCOM)" HRD Centre, Near Gopalakrishna temple, Shakthinagara, Mangaluru-575016. If some more establishment seek data during the process, they will also be invited to attend scrutiny.


